

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.rfoodsolutions.com, and Remarkable Academic Foods and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Remarkable Academic Foods include www.rfoodsolutions.com and Remarkable Foods LLC. Collection of your Personal Information

In order to better provide you with products and services offered, Remarkable Foods LLC may collect personally identifiable information, such as your:
